#### 4. RECIPIENTS AND AREAS OF COMMUNICATION OF PERSONAL DATA

Any dissemination of data is excluded, but they may also be processed by third parties in a contractual or conventional relationship for the execution and assistance of services provided and who act as data processors under article 28, GDPR. The provision of the newsletter service is carried out by a service company in the role of data processor and based outside the European Union.

Your personal data will not be subject to any fully automated decision-making process, including profiling, as referred to in article 22, paragraphs 1 and 4, of EU Regulation 2016/679.

#### **5. DATA RETENTION PERIOD**
